## ABOUT TRIDHARMA COLLEGE

Today, Tuesday, the Fifteenth of October, Two Thousand and Twenty-Fourth Year, at the Hall of the Faculty of Islamic Economics and Business (FEBI) Alauddin State Islamic University Makassar Indonesia, we the undersigned:

- 1. Prof. Dr. H. Abd. Rasyid Masri, M.Pd., M.Si., M.M., Position of Dean, Faculty of Da'wah and Communication, Alauddin State Islamic University, Makassar, address Jln. H.M. Yasin Limpo No. 36 Romang Polong Village, Somba Opu District, Gowa Regency, South Sulawesi Province, hereinafter referred to as, THE FIRST PARTY.

THE FIRST PARTY and THE SECOND PARTY, collectively hereinafter referred to as THE PARTIES.

### THE PARTIES first explain:

a. THE FIRST PARTY and SECOND PARTY, within the limits of their capabilities, authority and resources available to each party, will prepare facilities and infrastructure, personnel and other needs for this collaborative activity.

- b. In carrying out obligations in accordance with paragraph (a) above, both parties will assist each other as long as it does not interfere with the implementation of their respective institutional functions.
- c. THE SECOND PARTY has the right to determine, accept, reject or postpone the proposal from the FIRST PARTY based on internal considerations.

Based on the considerations as intended in letters a, b, and c, THE PARTIES agreed to enter into a Memorandum of Understanding regarding Improving the Tridharma of Higher Education with the following provisions:

#### CHAPTER 1

- Develop a collaborative network between the Dean of the Faculty of Da'wah and Communication, Alauddin State Islamic University, Makassar, Indonesia, and the Head of the Nur Inka Nusantara Madani Islamic Boarding School, United States.
- 2. Development of the Tridharma of Higher Education, namely the fields of education, research and community service.

#### CHAPTER 2

The scope of cooperation agreed in this Cooperation Agreement is:

- 1. Education
- 2. Study
- Community service

## CHAPTER 3

- 2. Notifications, instructions, correspondence or communications as intended in paragraph (1) of this article are deemed to have been received by the other party at:
  - a. The date of receipt as stated in the proof of receipt of the letter if sent by courier/post.
  - b. Date of sending the e-mail, and if the sending is not on a working day, then the e-mail is deemed received on the following working day.
- 3. THE PARTIES are obliged to notify the other party in writing if there is a change of address as intended in paragraph (1)

#### CHAPTER 4

- 1. This Cooperation Agreement is valid for 5 (five) years from the date of signing and can be extended according to the mutual agreement of the PARTIES.
- 2. Extension of this Cooperation Agreement is carried out by sending notification to the other party in writing no later than 1 (one) month before the end of this Cooperation Agreement.

#### CHAPTER 5

- 1. This Memorandum of Understanding is made in 2 (two) copies on paper with sufficient stamp duty and has the same legal force.
- 2. This Memorandum of Understanding comes into force on the date it is signed by THE PARTIES.
